MARKET REVIEW

The Nigerian Equity Market closed today's trading session **BULLISH**, leading to a **0.04%** gain in the **All-Share Index**. This resulted in a year-to-date return of **2.59%**. Consequently, the market capitalization settled at **N66.21trn**.

The market movers were the stocks of **UBA, ACCESSCORP, UCAP, ZENITHBANK** and **MTNN** etc.

Market Breadth which is the measure of investors' sentiment was **1.38x** compared to the previous day's market breadth of **1.09x**

The total number of advancers was **29**, chiefly led by stocks of **MAYBAKER, MBENEFIT** and **ETRANZACT** with **10.00%, 9.59%**, and **9.38%** gains each. Whereas, the number of decliners stood at **21** led by **ETERNA, ROYALEX** and **VERITASKAP** with **9.21%, 7.95%**, and **5.98%**, loss respectively. The Volume and Value drivers of the day's market trend were led by stocks of **ACCESSCORP, UBA** and **GEREGU**.

Transaction Volume for the day recorded **349.33 million**, compared to the previous day's volume of **440.52 million** trades valued at **₦ 15.08 billion** from the **12,450** deals executed. The number of stocks engaged at the end of today's trading session closed at **123**.

At the time of writing this report, **Brent Crude** was trading at **\$73.44/barrel**, **WTI** at **\$69.48/barrel**, **OPECBASKET** was trading at **\$74.91 barrel** while Gold was trading at **\$3,028.54/ounce** on the international Commodities Market. The U.S Dollar Index which is a measure of the value of the U.S. dollar relative to a basket of foreign currencies, closed at **104.24** index points.
