The Volume and Value drivers of the day's market trend were led by stocks of **ZENITHBANK**, **FCMB** and **TRANSPOWER**.

Transaction Volume for the day recorded **458.26 million**, compared to the previous day's volume of **423.42 million** trades valued at **₦ 14.08 billion** from the **12,213** deals executed. The number of stocks engaged at the end of today's trading session closed at **127.** 

At the time of writing this report, **Brent Crude** was trading at \$73.07/barrel, **WTI** at \$69.45/barrel, **OPECBASKET** was trading at \$74.87/barrel while Gold was trading at \$2,835.99/ounce on the international Commodities Market.
