The Nigerian Equity Market closed today's trading session **BEARISH**, leading to a **0.04%** decline in the **All-Share Index**. This resulted in a year-to-date return of **31.09%**. Consequently, the market capitalization settled at **N59.40trn**.

The market movers were the stocks of ARADEL, UBA, TRANSCORP and ZENITH etc.

Market Breadth which is the measure of investors' sentiment was 1.36x compared to the previous day market breadth of 0.81x.

The total number of advancers was **30**, chiefly led by stocks of **SKYAVN**, **UPL**, and **EUNISELL** with **10.00%**, **10.00%**, and **9.93%** gains each. Whereas, the number of decliners stood at **22** led by **JAIZBANK**, **PZ** and **ABCTRANS** with **10.00%**, **10.00%**, and **9.63%**, loss respectively. The Volume and Value drivers of the day's market trend were led by stocks of **JAIZBANK**, **UBA** and **MTNN**.

Transaction Volume for the day recorded **583.96 million**, compared to the previous day volume of **399.32 million** trades valued at **₦ 15.3 billion** from the **10,028** deals executed. The number of stocks engaged at the end of today's trading session closed at **125.**

At the time of writing this report, **Brent Crude** was trading at **\$72.16/barrel**, **WTI** at **\$68.19/barrel**, **OPECBASKET** was trading at **\$72.06/barrel** while Gold was trading at **\$2,777.33/ounce** on the international Commodities Market. The U.S Dollar Index which is a measure of the value of the U.S. dollar relative to a basket of foreign currencies closed at **104.09** index points.
